**TITLE:** CONCERNING THE SUNSET REVIEW OF THE DENTAL ADVISORY COMMITTEE, AND, IN CONNECTION THEREWITH, IMPLEMENTING THE RECOMMENDATIONS OF THE DEPARTMENT OF REGULATORY AGENCIES TO CONTINUE THE ADVISORY COMMITTEE.

**Summary of Legislation**

The bill continues the Dental Advisory Committee in the Department of Public Health and Environment (DPHE), which is scheduled to be repealed on July 1, 2013, and makes the following changes to the committee:

- reduces membership on the committee from 10 members to 7 members;
- adjusts the required make up of the committee; and
- makes the committee permanent with no future repeal date.

**Background**

The Dental Assistance Program provides grants to dental providers who agree to serve low-income seniors. The Dental Advisory Committee advises the DPHE on the operation of the program, reviews grant applications, and makes recommendations to the State Board of Health concerning the number of eligible seniors to be served and for the allowable procedures and reimbursement rates for participating providers. The Dental Assistance Program did not receive funding in FY 2010-11 and FY 2011-12, and the advisory committee did not meet in these years. The program received \$3.0 million in funding in FY 2012-13, so the advisory committee is expected to renew its activities during the current fiscal year.

**State Expenditures**

By continuing an advisory committee scheduled to expire, the bill increases expenditures in the DPHE by a minimal amount. A small amount of staff time and operating expenses (less than \$5,000) is required to support the committee, including holding committee meetings, conducting policy research, and checking the completeness and accuracy of grant applications to be review by the committee. These tasks can be accomplished by existing staff at the DPHE. Members of the advisory committee serve without compensation. No adjustment in appropriations is required to continue the Dental Advisory Committee.
